To begin this year, our Student Senators have shown their ability to be sensitive to the needs of individuals through mental health literacy days, resources like the John Howard Society 'Sidewalk Talks', and resources for new and existing students such as 'get to know you' events, listening opportunities, peer tutoring, and extracurricular fairs to help students feel comfortable integrating into our school communities.

In addition, fairness involves empathy and accountability. By understanding others' experiences, fair leaders can make more compassionate decisions, ensuring their actions don't unintentionally harm or disadvantage anyone. They also hold themselves accountable for their actions, willing to admit mistakes if they have acted unfairly and ready to correct them to maintain justice in their dealings.

KPR values the principle of acting justly, and students have developed a powerful sense of justice within our school communities. Peterborough City and County Accommodation Planning

10.1.1 Jaclyn Daniels

J. Daniels, resident of Township of Cavan Monaghan, spoke to the suggested concepts from the Peterborough City and County Accommodation Planning specifically with respect to the differences between rural and urban communities, special programs at Crestwood Secondary School (SS) and sports at Crestwood SS and Kenner Collegiate Vocational Institute (KCVI), as well as suggesting that the implementation of the suggested concepts will cause longer bus rides.

On behalf of Kenner Intermediate School educators, highlights of the many academic and social opportunities that are available to students at Kenner Intermediate was shared. It was

indicated that Kenner Intermediate School educators take immense pride in the school community. It was requested that the trustees keep these dedicated educators in mind as they make decisions about the schools that they serve.

D. D. Warda highlighted the value and dedication of educators and the negative impact of divisive comments about the KCVI community. It was requested to regard KCVI for it's potential and not it's reputation.

11. **DIRECTOR'S UPDATE**

Director Russo reported 36,000 students were welcomed across KPR in September. Gratitude was expressed to everyone that supported start-up in classrooms across the district.

KPR staff are inspiring students to excel in learning to succeed in life in enrich communities. Staff have returned to school with a clear focus and direction that comes from the Ministry of Education and the Multi-year Strategic Plan. Superintendents and executive officers continue to work with staff to advance the goals and actions of the newly revised 2024-2025 KPR Board Action Plan. The guiding principles of learning matters, belonging matters and relationship matters remain at the forefront of KPR's work.

During school visits, Director Russo noted that schools in both elementary and secondary panels displayed artifacts of the school's commitment to literacy, math, mental health and well-being as well as explicit ways of welcoming families and community members into the learning spaces.

The first professional activity day is to be held Friday, September 27, 2024, where most educators will be learning about literacy and math and engaging in learning around Non-Violent Physical Crisis Intervention, safety plans, code of conduct and other ways to support students in classrooms.

As a result of new legislation there are changes to the use of personal electronic devices in schools. From anecdotal evidence, students are doing well with the new expectations. This shows that implementation plans have been well received and the new expectation is having a positive impact on school climate.

Student Trustees Singh and Poley we welcomed to the Boardroom table and Director Russo spoke to the leadership they demonstrated at the first Student Senate meeting of 2024-2025.

It was highlighted that the National Day for Truth and Reconciliation is on September 30th. It is essential for school communities within KPR to come together in reflection and in learning on the day and leading up to it to offer a meaningful opportunity to deepen understanding of the ongoing impacts and history of the residential school system for Indigenous peoples. Schools will focus on educating about the harm caused by residential schools, honouring residential school survivors and their families, and remembering the children who never returned home. Director Russo encouraged everyone to wear an orange shirt on September 30th and to amplify the message that every child matters as a powerful affirmation of our commitment to raising awareness about the residential school experience and honouring the healing journey of Indigenous lives impacted by these schools.

13. **STUDENT TRUSTEE REPORT**

Student Trustee Singh highlighted the activities and initiatives across KPR as the new school year begins such as Grade 9 Orientation, Football Jamboree, sports tryouts, and student council elections, to foster school spirit and community bonding.

The student trustees aim to recognize student voices, prioritize well-being and safety, and provide new opportunities. Student Trustee Poley proposed encouraging student voice and excellence through accolades and personalized letters or certificates from the Board. The creativity and initiative fostered at KPR schools was emphasized while looking ahead to student events like Grade 9 Days, back-to-school dances, and spirit days.

Student Trustee Report

Ben Poley and Aanya Singh

The Student Senate met for the second time this year on Monday, October 7, 2024. As part of Student Senate reports, every school could add to Kawartha Pine Ridge District School Board's (KPR) commitment to Student Voice. These reports provided information about September's start-up in each school, including information about how schools commemorated the National Day of Truth and Reconciliation (formerly known as Orange Shirt Day), as well as describing events, clubs, and sports. There are lots of exciting curricular and extracurricular activities taking place within all KPR schools!

In remembrance of the National Day for Truth and Reconciliation, we heard that schools across KPR honoured this day in a variety of ways, such as informative videos and announcements, class activities, and opportunities to engage in meaningful pauses such as outdoor land acknowledgements, opportunities to create, and smudging. Student senators reported strong participation at each school. On the topic of clubs and sports, senators reported an active start to the school year at all KPR schools, and a diverse variety of school organizations for students to get involved with. We heard about eco clubs, debate clubs, Genders and Sexualities Alliances (GSAs), peer tutoring, bands, choirs, and musical productions. Finally, many KPR schools have already held their Terry Fox events, and all schools involved reported important levels of student engagement.

Trustee Singh and I are focused on enhancing opportunities and connections between elementary and secondary KPR students. Connecting student senators with intermediate student voice in KPR schools is our first way of bridging these groups. Senators shared how their student councils are organized and provided information about current connections within their schools and feeder schools. We heard that schools which had intermediate schools within their building were already exploring some form of intermediate representation or voice through communication or even collaboration with their intermediate student council counterparts. KPR student senators will continue to share strategies and problem solving in connecting with feeder schools and their intermediate leaders.

In terms of prominent issues discussed, student senators reported on the general mood in their school community. This involved discussions of mental health, students' reactions to the new cell phone policy, as well as other school-specific concerns:

- KPR schools have been making efforts to check in on the mental health of their students, especially in the form of Google forms and surveys.
- The new cell phone policy has been met with mixed reactions and some implementation rough spots. Student senators reflected how it can be ineffective when not consistently enforced, and how it has been a shift for some students beyond their normal expectations. Senators also discussed how in some cases, students were finding it easier to focus and learn.
- Senators also reported many safety concerns, including behavioural issues amongst intermediate students and issues with busing and transportation safety.

Finally, on Friday, October 11th, the student senators, alongside Trustee Singh and I attended a leadership development session at Larryland. With student senators from <u>all</u> high schools, it was a wonderful experience and an even better opportunity to get to know each other in a meaningful way. Student senators learned important leadership skills, such as taking their time to select a good path, working in groups, and helping those who need assistance. Students who participated in this event unanimously agreed that it was engaging and impactful, and we would like to express our gratitude to the board for having provided this incredible opportunity.

Trustees A. Lloyd and J. Klassen Jeninga updated the committee on events and initiatives being undertaken by the board.

Special Education Plan Activity

The committee, in groups of two, reviewed and discussed the following Special Education Plan standards:

Standard 1 – Model of Special Education

Standard 2 - Identification, Placement and Review Committee (IPRC) Process

Standard 4 – Individual Education Plans

Standard 6 – Specialized Equipment

Standard 7 – Transportation for Students with Special Education Needs

Standard 8 – Transition Planning.

Committee members provided feedback and suggestions. The remaining Special Education Plan standards will be sent to committee members for review for the November 2024 meeting.

Administrative Updates

Superintendent Sepkowski updated the committee on the professional learning offered to new special education resource teachers (SERTs) in September. Professional learning for SERTs is created by the instructional leadership consultants and the system principals of special education. This learning highlighted Kawartha Pine Ridge District School Board's (KPR) processes, meetings and pathways including individual education plans, programming supports, system programs, KPRlite, specialized equipment allocation, transportation and positive student behaviour support plans.

Superintendent Sepkowski provided an update on the Kindergarten Initiative program that was introduced to elementary schools in September. Initially, there were 34 referrals, which has since increased to 46. The Special Education Department is currently reviewing these referrals to determine the appropriate next steps, including conducting classroom observations and collecting data.

The committee heard that the Special Education Department is developing a Modified Schedule Plan that will outline the procedure that school principals must follow to modify a student's instructional school day. Further information will be shared with the committee after the plan has been presented to the senior administration team.

Superintendent Sepkowski reported that a Special Olympics soccer tournament for KPR's Learning and Life Skills (LLS) students was held at Crestwood Secondary School. The Kenner Collegiate Vocational Institute LLS students emerged victorious, but most importantly, everyone had a great time.

Superintendent Sepkowski asked for the committee's assistance in developing programs or obtaining information from community partners to help KPR LLS students better understand healthy relationships, boundaries, and sexuality.

- K. Hill, Special Education Advisory Committee (SEAC) representative for Canopy Support Services, shared information about a 14-week program called Healthy Sexuality and Relationships developed by Mackenzie Health. There are agency partners across Southern Ontario with specific programming who present learning about online safety, relationships, boundaries, and consent, and there could be programming available at a cost to the school board.
- J. Hunter, SEAC representative from the Curve Lake First Nation, shared information about a prevention workshop from an organization called Children of the Street. Workshops provide students with knowledge and tools to keep themselves and their friends safe from sexual exploitation both offline and online.
- S. Micieli, SEAC representative from Grandview Kids, reported that Holland Bloorview Kids Rehabilitation Hospital in Toronto can provide resources and information.

Department Introductions and Updates

<u>Guest Speaker – Rory Burke, Director of the Accessibility for Ontarians with Disabilities Act (AODA) Compliance Branch</u>

R. Burke delivered a presentation on the importance of accessibility and the role of the AODA. R. Burke emphasized the critical role of schools in ensuring every student has an equal chance for success and discussed the modern regulatory approach to compliance and enforcement, including audits, inspections, and enforcement tools for non-compliant organizations. A snapshot of school board compliance was provided, highlighting areas of strength and areas for improvement. The committee discussed the impact of compliance on organizational culture, proactive measures for school design, and the timeline for making older buildings accessible.

Accessibility for Ontarians with Disabilities Act (AODA) Desk Audit

- D. Knezevic presented the AODA Compliance Checklist, discussing the progress and compliance efforts related to accessibility for persons with disabilities. The presentation included the creation of policies, system engagement, and the submission of compliance reports.
- D. Knezevic highlighted in-person audits, the bi-annual compliance report, and ongoing efforts to ensure accessibility across different departments and services. D. Knezevic briefly spoke to the rapid nature of Ministry of Seniors and Accessibility requests for information and the importance of timely responses to maintain compliance and confidence in the work being done. A. Anirud highlighted the integration of administrative regulations and the launch of accessibility training modules (Accessibility 101) for staff.

Accessibility Inclusion Exercise

D. Knezevic presented a learning exercise to the committee which discussed a hypothetical scenario involving a student with dyslexia. In small groups, the committee was asked to consider the questions provided and discuss possible solutions to inclusion, accommodation plans and equity consideration that would need to be addressed in the scenario and then provide feedback.

Accessibility 101 Launch

A. Anirud reported on the launch of the Kawartha Pine Ridge District School Board's (KPR) Accessibility 101 training program. The training will be available on the KPR Learns platform with a goal to ensure that all staff have a baseline understanding of accessibility and its applications. A. Anirud highlighted that the module was designed specific to KPR with identifiable staff and buildings. D. Knezevic stated the stand-alone module has been designed to be accessible and should work with any assistive technologies.

Math Achievement Action Plan Report 1

Drew McNaughton, Associate Director of Education, noted that this will be the first of three Math Achievement Action Plan updates for the 2024-2025 school year. In support of the Kawartha Pine Ridge District School Board (KPR) Math Achievement Action Plan, staff will be engaging in math professional learning at various professional activity days throughout the school year. Additionally, priority school teams will be meeting up to five times throughout the year to engage in ongoing learning as KPR seeks to grow in evidence-informed practices so students' learning and efficacy is reflected in achievement.

- J. McIlmoyle Parsons, Principal of Teaching and Learning K-12 (elementary focus), reported that as part of the Ministry of Education's 2024-2025 Responsive Education Programs (REP) allocation, school boards were provided with funding to support math achievement (e.g., math digital tools, math facilitators). The 2024-2025 KPR priority schools, as outlined by the Ministry of Education, were also shared. It was reported that baseline data gathered in September 2024 will be used to support the development of KPR's Math Achievement Action Plan.
- J. McIlmoyle Parsons shared that the Special Education Department and Teaching and Learning K-12 Department were approved for the Removing Barriers for Students with Special Education Needs grant. The two departments will partner to analyse evidence of learning from students with special education needs to explicitly monitor the impact of evidence-informed instruction for these learners.

Safe and Caring Schools Update

Superintendent Gohil reported that KPR is committed to creating and sustaining safe and caring schools for the purpose of promoting learning, achievement and well-being. The Safe and Caring Schools Team supports a wide range of system and school level actions in keeping with this commitment in collaboration with other KPR departments.

S. Johnson, System Principal of Alternative, International and Continuing Education and Safe and Caring Schools, shared the following information:

- Board Policy ES-1.1, Safe and Caring Schools: Provides direction on leading safe and inclusive environments within KPR schools.
- Safe and Caring Schools Advisory Committee: Established in October 2023 to support a pilot project in 12 schools, implementing Positive School Climate Teams.
- Ministry of Education Update: Updated Policy Program Memoranda (PPM) 128 on April 28, 2024, highlighting the use of tobacco, e-cigarettes, student mobile devices, and social media.
- Violence Threat Risk Assessment (VTRA) Protocol: Helps principals take immediate steps to protect student and staff well-being with the support of local agencies and police services.
- Positive School Climate Teams: Actively implemented in 2023-2024, leading to the creation of the Positive School Climate Team Handbook released in August 2024.
- School Climate Surveys: Data collected in June 2024 will guide efforts to support safe and inclusive spaces for all staff and students.
- Bullying Prevention and Intervention Plan: Revised template to be released in November 2024, documenting work related to positive school climates and bullying prevention.
- Administrative Regulation ES-1.1.1A, Appendix A: Discipline/Promoting Positive Student Behaviour/Code of Conduct: Revised to include information on the use of tobacco, e-cigarettes, and student mobile devices.
- Suspension and Expulsion Data: Total suspensions increased relative to board enrolment, but that the number of students being suspended has decreased from the 2022-2023 to the 2023-2024 school year with the length of suspensions increasing. Expulsions have increased, but efforts are ongoing to support students with a trauma-informed and culturally responsive approach.
- Critical Analysis of Suspension Data: Continued engagement in 2024-2025 to review progressive discipline approaches, proactive intervention strategies, and alternatives to expulsion.

September 27, 2024 Professional Activity Day Report

Associate Director McNaughton reported that the September 27, 2024 Professional Activity Day addressed topics mandated by the Ministry of Education, including literacy and mathematics for elementary schools, and literacy and code of conduct for secondary schools. The remainder of the day allowed for schools to engage in school improvement planning.

2024-2025 School Year Start-up Overview

R. Wierenga reported that school start-up has been busier than normal mainly due to the change in route assignments as a result of the recent Request for Proposal (RFP) process that was awarded in June 2024. As a result, STSCO has two new bus operators, C. Smith Bus Lines in the Northumberland area and Wheelchair Accessible Transit (WAT) in the Peterborough area.

During the route planning process, it became evident that there was a shortage of drivers for the Peterborough area. As a temporary measure, certain routes were consolidated to avoid routes being cancelled. This resulted in longer than normal ride times for some families. All routes are now restored to ride times that meet guidelines.

Overall, bus operators in Peterborough and Northumberland have performed extremely well through school start-up. There continues to be significant delays in the Clarington area as the operator in this region did not have a sufficient number of vehicles to cover their assigned routes. This operator has accounted for 74.4% of all late bus routes during the month of September. STSCO has noted a slight improvement in the service delivery in this area and expects that service should be restored by the end of October.

Other updates provided included the use of public transit being expanded in Peterborough this year and continuing in the Clarington area where eligible students receive a public transit pass.

Opt-In for Transportation – Update

R. Wierenga provided an update on the Opt-In for transportation noting 84.3% of the 20,396 eligible students within the board's jurisdiction have opted-in for transportation services. The number of eligible students who did not opt-in for transportation is 3,212 (15.7%).

The Opt-In program has enabled STSCO staff to create more efficient bus routes and reduce the number of routes this year.

2024 Start-up Compliance Update

STSCO requires annual documentation from school bus and taxi operators including the submission of updated Workplace Safety and Insurance Board (WSIB) certificates, insurance certificates and commercial vehicle operator's registrations (CVOR) as they expire.

Bus operators are required to submit seating plans for all their assigned routes, Ministry of Transportation (MTO) inspection reports, MTO notifications, route audits and collision/incident reports (as required). Bus operators are also required to submit documentation to confirm completion of their assigned bus evacuation drills.

R. Wierenga was pleased to report that all STSCO bus and taxi operators and are compliant, and compliance monitoring will continue throughout the school year.

2024 First Rider Safety Program Update

R. Wierenga reported that STSCO's annual First Rider event was held in August at a school in each region. The event is important for students riding the bus for the first time to understand and familiarize themselves with the rules and safety in and around the bus. It also offers an opportunity for parents to speak with staff to answer any questions or discuss any concerns they may have.

Each site had a minimum of one large bus and one small accessible bus. At the Peterborough and Northumberland locations crossing guards provided a demonstration of safe street crossing. STSCO hopes to offer crossing guard demonstrations in Clarington as well next year. STSCO is pleased to report there was an increase in attendance at all three event locations and is hopeful the numbers will continue to increase each year.

2024-2025 School Bus Safety Training Update

R. Wierenga announced the return of in-person school bus safety training at elementary schools this year. This crucial student safety initiative, funded by the Ministry of Education, is specifically designed for students in Kindergarten through Grade 3 and Grades 4 to 8.

Each session is an engaging and interactive experience held in the school's gymnasium, lasting roughly 30 minutes. Key areas of safety training include:

- walking to your bus stop,
- waiting at your bus stop,
- the danger zone around the school bus,
- crossing in front of your school bus from your bus stop,
- boarding your school bus,
- riding on your school bus, and
- emergency evacuation.

INFORMATION ITEMS

Summer Capital Project Update

Superintendent Foster reported the Ministry of Education (MOE) launched the 2024-2025 Capital Priorities Program on July 8, 2024, with approvals expected in the spring of 2025.

The program aims to build modern schools faster, better utilize school capacity and ensure value for taxpayer dollars. The Long Term Accommodation Plan (LTAP) 2020-2025, 2024 edition outlines the board's capital priorities. The board's priorities for capital funding requests and updates related to the LTAP were provided to the Resource Committee in both June and September of this year.

There were five proposals supporting four projects that were submitted to the MOE for consideration.

Newcastle, Foster Northwest Neighbourhood, Grady/Ruddell Road:

The first priority ranking was for a new build in Newcastle within the Foster Northwest neighbourhood at a board-owned property at Grady Drive and Ruddell Rd.

Significant enrolment pressures are being experienced within the Newcastle area due to ongoing residential development, specifically putting pressures on Newcastle Public School (PS) and The Pines Senior PS. Given the long-standing safety concerns that the board has with the location of the intermediate and secondary schools on Highway 115, administration provided the MOE with two options for consideration for this site.

- Option 1-A includes a request for a Junior Kindergarten (JK) to Grade 12, 1,400-pupil-place school plus a three-room child care centre.
- Option 1-B includes a JK to Grade 6, 481-pupil-place school plus a three-room child care centre.

Millbrook. Towerhill North. Fallis Line:

The second priority ranking was for a new build in Millbrook within the Towerhill North subdivision. Ongoing residential development in the Township of Cavan Monagan has created significant enrolment pressures within the Crestwood Family of Schools, and in order to alleviate some of this pressure, a request for a 481-pupil-place JK to Grade 8 school plus a four-room child care centre was submitted to the MOE.

Buckhorn Public School, Addition:

The third priority ranking was an addition at Buckhorn PS, as this area has been experiencing slow but steady enrolment growth. Last year, the school was at 140% utilization rate with 165 students. Although this growth has been previously managed with portable classrooms, the additional growth expected will put continued pressure on the school infrastructure, such as the gymnasium, the library and washrooms. As a result, a request for 121-pupil-place addition and a three-room child care centre has been requested.

Merwin Greer Public School, Addition:

The fourth priority ranking was an addition at Merwin Greer PS given the area's recent residential development activity. Last year, the school was at a utilization rate of 116%, with 124 students. As significant growth is expected to come out of the new development proposals in the area, a request for 141-pupil-place addition and a four-room child care centre was submitted to the MOE.

Superintendent Foster spoke to the project readiness noting architects were engaged to complete architectural drawings and cost estimates to maintain momentum and be ready to proceed if awarded any projects.

In terms of budget implications, approved capital priorities projects are funded by the Ministry of Education, Capital Priorities Programs and any pre-acquisition costs incurred by the Board prior to MOE approval are reported as unsupported capital costs.

Northglen Neighbourhood School Update

Superintendent Foster reported that the Northglen neighbourhood school was approved as part of the MOE's 2021-2022 Capital Priorities Program. A 769-pupilplace Junior Kindergarten (JK) to Grade 8 school was approved along with a four-room childcare centre (1 infant, 1 toddler, 2 preschool) at the Northglen neighbourhood school site.

Following an extensive community engagement process, at the March 26, 2024 Board meeting, the Board of Trustees approved the boundary for the new Northglen neighbourhood school. A map of the new boundary is illustrated in Appendix A. An implementation plan for the impacted school communities is outlined in Appendix B. Most notably, the Northglen neighbourhood school will open as a JK to Grade 7 school in 2025, and transition to a JK to Grade 8 school in 2026. By doing so, it will allow the students that are transitioning to the new school and are in their last year before graduating to graduate with their current classmates out of the school that they have been attending. All other students impacted by the new boundary who will be in JK to Grade 7 will move to the new school for September of 2025.

Superintendent Payne provided an update on the build noting progress since the groundbreaking ceremony that took place at the new school site in June 2024. He confirmed that construction at the new site is underway and progressing well.

It is anticipated that the structural phase will be completed on schedule and the progress will continue to be monitored closely to ensure that the high standards of quality and safety are being maintained.

Superintendent Foster noted that the capital costs to build the new Northglen neighbourhood school is funded through the MOE Capital Priorities Program. Included in the 2024-2025 budget was funds to support the purchase of start up items for the school that fall outside of the capital funding allocation. Therefore, there should be no additional impact on the 2024-2025 budget as result of the new build.

Boundary Adjustment Review – Bowmanville Area Schools Update

Superintendent Foster reported that as the school boundaries for the Northglen neighbourhood school were established, consideration for potential boundary adjustments was given to Bowmanville/West Clarington area schools as well with the goal of mitigating capacity and space limitation challenges that were being experienced.

Following an extensive community engagement process, at the March 26, 2024 Board meeting, the Board of Trustees approved the boundary adjustments. Appendix C illustrates the new school attendance areas that were approved.


The new boundaries will be in effect September, 2025 for new registrations only. Existing students within these boundaries have the option of staying at their current school or moving to the new boundary school. An implementation plan for the impacted school communities is outlined in Appendix D.

Superintendent Foster noted that there are no impacts on the 2024-2025 budget as a result of the approved boundary changes.


