Director Russo spoke to the Kawartha Pine Ridge District School Board (KPR) Board Action Plan (BAP) second pillar which:

 Honours Indigenous knowledge and ways of knowing, engages in Truth and Reconciliation, and elevates First Nations, Métis and Inuit cultures, perspectives, and histories.

- Creates safe, inclusive spaces where belonging, wellbeing, and mental health supports student engagement, and the diversity and lived experiences of students and staff are valued and reflected in learning and working environments.
- Embeds principles of human rights to ensure equity and inclusion for all.

November is Indigenous Peoples Awareness Month at KPR, with learning focused on topics such as Indigenous excellence, treaties, International Inuit Day, Louis Riel Day and the United Nations Declaration on the Rights of Indigenous People. A lookbook of this learning will be presented at the December Board meeting.

The 23rd Annual Parent Conference was held on November 23, 2024 featuring keynote speaker Dr. Robin Hanley Defoe, who presented on everyday resiliency. The conference was well-received. The participants rated it highly and appreciated the practical strategies shared.

A human rights system survey was conducted by KPR's Commissioner's Office of Human Rights, Equity, and Accessibility (HREA) to gather information about staff knowledge of the human rights principles. Results showed confidence in knowledge but identified gaps. The findings of this survey will guide the development of a human rights learning module.

Student Trustee Report

This month's Student Senate meeting was well-attended, with most trustees present in person or online. Throughout the meeting, Student Senators shared school reports describing the events going on at their schools and considering problem-solving challenges schools are facing. In terms of school events, Student Senate heard about food drives and community fundraisers, as students and educators give back to the community in time for the winter holiday season. Student Senators also shared information about fun events such as dances and semi-formals. In terms of challenges, Student Senators continued last month's dialogue about the implementation of new school safety policies, including vaping, misuse of bathrooms, and support for positive school climate. To address these concerns, the Student Senate discussed the ways to gather student voice on a large scale and are looking at initiating a student survey to gather data and summaries of student concerns which can be brought to the Board.

In other business, the Student Senators discussed the constitution. The role of "Regional Representative" was reviewed and then Student Senate voted to implement these roles as a part of the Student Senate structure this year. The Student Senate feels that the "Regional Representative" role will aid in Senate efficiency regarding regional concerns. All parties present agreed and the elections for these positions will be held next month, one for each of the three regions of our board. Additionally, the Student Senate is looking ahead as a team to policy review. Before the next meeting, Senators will read the KPR Student Government policy, and for the first time in its history, the Student Senate will have the opportunity to participate in the editing and revision of a policy document. All Student Senators appreciate this opportunity to empower student voices in a tangible way.

Further, Student Senators discussed their initiative for intermediate outreach and communication. Student Senators were excited about the possibility of using social media videos as an opportunity to advertise high school activities and leadership structures to intermediate students. As it stands, Student Senate would collaborate with the individual regions to produce short one to three-minute videos explaining their local schools, events, sports, and student council activities to engage intermediate students in the opportunities in upcoming grades.

Finally, we were able to announce the Board's support of the creation of KPR Kudos and start this initiative as a Student Senate. We would like to thank the Board for their support with this initiative. This month the KPR Student Senate would like to extend KPR Kudos to a few individuals who were nominated by schools.

- From Clarke High School, we would like to recognize Reilly Louden Timms for her support for "Friends of the Library" and her role in forming connections between intermediate and secondary students.
- From Thomas A. Stewart Secondary School, Grade 12 student Tori Beasley for spearheading the club "Service Griffins", which focuses on community service and volunteering.

BACKGROUND

1. At the February 28, 2024, Resource Committee meeting, staff presented an initial report for the City and County of Peterborough Accommodation Planning: Background Study, which rationalized the need for a school attendance area, program offering and/or grade/cohort review.

- 2. At the April 3, 2024, Resource Committee meeting, Administration and Planning Services staff prepared and presented four accommodation planning concepts, which were intended to balance enrolment across the City and County of Peterborough schools.
- 3. A community engagement meeting was held on Wednesday, April 17, 2024, at Kenner Collegiate Vocational Institute (CVI). The meeting was organized in an open house format. The meeting provided community members with the opportunity to review the accommodation planning concepts and ask questions of administrative staff and trustees. Other opportunities for community engagement included an electronic feedback option.
- 4. Administration considered the community feedback, together with the following guiding principles identified at the start of this project to evaluate the proposed solutions:
 - providing high quality programs for all students,
 - developing long-term, sustainable plans that balance enrolment,
 - · maintaining walkable routes to school, and
 - maintaining efficient transportation services.
- 5. Following the community engagement meeting and after review of the feedback provided, administration presented two refined concepts (Concept A.1 and Concept E) at the Resource Committee meeting on September 11, 2024.
- 6. Community engagement meetings were held providing community members with the opportunity to review the revised accommodation planning concepts and ask questions of administration and trustees. An electronic feedback option was also available.

- 7. Following the community engagement meetings and after review of the feedback provided, administration presented one additional concept (Concept A.2) to the Resource Committee at the November 6, 2024 meeting.
- 8. At the November 27, 2024 Resource Committee meeting, a full summary of the community engagement feedback was shared with the committee. At that time, administration removed Concept E from consideration.

STATUS

- 9. Concept A.1 and Concept A.2 are before the Board for final decision. For reference, the following appendices are attached:
 - Appendix A are the updated enrolment projections for Concept A.1.
 - Appendix B are the updated enrolment projections for Concept A.2.
 - Appendix C is a summary of the cost analysis for each concept.
 - Appendix D is a revised comparison of the remaining two concepts against the guiding principles.

Trustee A. Lloyd was acclaimed as Chairperson of the Resource Committee and assumed the chair.

DELEGATIONS

Committee Chairperson, Angela Lloyd, welcomed Jaclyn Daniels, resident of the Township of Cavan Monaghan. She addressed the committee and spoke to Concept A.2 from the Peterborough City and County Accommodation Planning. J. Daniels shared her belief that Concept A.2 is superior to meeting the guiding principles, while lowering transportation costs and keeping efficiencies in busing and walkability. J. Daniels also noted that she feels it supports a balanced enrolment at Crestwood Secondary School (SS).

INFORMATION ITEMS

City and County of Peterborough Accommodation Planning Update

Superintendent Foster reported to the committee that at the February 28, 2024 Resource Committee meeting, staff presented an initial report which rationalized the need for a school attendance area review, program offering and/or grade cohort review for the City and County of Peterborough. At the April 3, 2024, Resource Committee

meeting, four concepts were shared. Community feedback was gathered at a community engagement meeting on April 17, 2024 and through electronic feedback.

Administration has considered community feedback, together with the four guiding principles which include providing high quality programs for all students, developing long term sustainable plans that balance enrolment, maintaining walkable routes to school and maintaining efficient transportation services. In reviewing the community feedback and evaluating the proposed concepts against these principles, administration presented two refined concepts, Concept A.1 and Concept E at the September 11, 2024 Resource Committee meeting.

Superintendent Foster shared that in October 2024 further community engagement meetings were held and after reviewing the feedback received, administration presented one additional concept, Concept A.2 at the November 6, 2024 Resource Committee meeting. Following this meeting, there was further analysis and consideration of feedback from the community on Concept A.1, Concept A.2 and Concept E. The decision was made to remove Concept E for the following reasons:

- Although secondary enrolment across the Peterborough region is relatively balanced in this concept, enrolment at Crestwood (SS) decreases over the long term with utilization rates falling below 80%.
- Boundary adjustments between Queen Mary and Queen Elizabeth Public Schools (PS) impacts students' ability to walk to school. Some students who would have had the ability to walk to school would now require bus transportation.
- The relocation of the Grade 7 and 8 cohort from Adam Scott Intermediate School
 (i.e., English stream students from Edmison Heights and
 R.F. Downey PSs) requires students to be transported to Queen Mary PS, whereas
 some of these students would walk to Adam Scott Intermediate School.
- From a programing perspective, it is not considered optimal to have a singletrack French Immersion program in the intermediate school.

A final decision report will be presented at the December 10, 2024, Board meeting with Concept A.1 and A.2 for consideration.

<u>Guest Speaker – Lila Refaie, Bilingual Intake Lawyer and Student Programs Lead for ARCH Disability Law Centre.</u>

L. Refaie delivered an overview of ARCH Disability Law Centre and its services, representing organizations of persons with disabilities in interventions at higher courts. Their focus areas include human rights and discrimination law, accessibility laws, attendance services, transportation law, and decision-making rights.

L. Refaie outlined ARCH's mandate to legal advice and information in:

- providing guidance to individuals with disabilities on their legal rights and options.
- Law Reform: Working to change laws and policies to better protect and promote the rights of people with disabilities.
- Legal Education: Providing resources and materials to educate the public and legal professionals about disability rights.
- Test Case Litigation: Taking on significant cases that have the potential to create systemic change.

L. Refaie also addressed the issue of Refusal to Admit, Sec. 265-(1) (m) of the Education Act (exclusions) in schools, where principals refuse to admit students due to safety concerns, often involving disability-related behavior. Exclusions can last for an undetermined amount of time and are not meant to be disciplinary, though they are often used that way. L. Refaie reminded the committee that schools have a duty to accommodate students even when they are excluded, including updating Individual Education Plans (IEPs) and ensuring necessary accommodations are in place.

However, there is no mandatory tracking of exclusions, making it difficult to know how many occur. In conclusion, L. Refaie emphasized the importance of understanding the legal framework around exclusions and the ongoing duty to accommodate students with disabilities.

Accessibility for Ontarians with Disabilities Act (AODA) Desk Audit

Kawartha Pine Ridge District School Board (KPR) was selected by the AODA Compliance Unit to complete a desk audit which ran from July to October 2024 and included multiple requests for information regarding emergency planning communications, transportation, and educator training. The desk audit officially concluded on October 30, 2024.

Human Rights System Survey Update

A. Anirud and D. Knezevic reported on the KPR's Human Rights system survey. The survey, which ran from October 10 to October 31, 2024, aimed to assess staff knowledge of human rights principles and the Ontario Human Rights Code. The survey gathered responses from 1,502 staff members, representing 25.2% of KPR's permanent staff. Key findings indicate varying levels of confidence in human rights knowledge, general awareness of KPR's human rights policies, and moderate awareness of the Commissioner's Office of Human Rights, Equity and Accessibility (COHREA) and the complaints process. The report aligns with KPR's Board Action Plan and outlines next steps, including developing a Human Rights Learning Module and enhancing communication channels.

Special Education Plan Update

Superintendent Sepkowski presented two of the updated and finalized Special Education Plan standards that will be submitted to the Ministry of Education in July 2025. The following Special Education Plan standards have been completed and approved by the committee:

Standard 3: Special Education Placements Provided by the Board

Standard 9: Roles and Responsibilities

Administrative Updates

Superintendent Sepkowski provided information on the November 22, 2024, secondary professional activity day where secondary teachers met at three different secondary schools across the board to receive learning around Artificial Intelligence and subject

specific topics. The secondary school learning and life skills (LLS) teachers also met in three different secondary schools and received learning around math, literacy, and sexual health, consent and healthy relationships. The LLS teachers shared two problems of practice that are being faced in LLS classrooms: racist language which is being used in classrooms and video game addictions and asked if these can be shared with community agencies and the Special Education Advisory Committee (SEAC) for any resources or support.

Superintendent Sepkowski announced that the Ministry of Education is modernizing the special incident portion (SIP) funding model and are requesting data from each public school board for students with complex profiles that fit the criteria.

Superintendent Sepkowski together with J. Shuttleworth, System Principal of Special Education, attended a Ministry of Education meeting focusing on Policy Program Memorandum 140 (PPM 140): Incorporating methods of applied behaviour analysis (ABA) into programs for students with autism spectrum disorders (ASD). The Ministry of Education confirmed meetings with Autism Ontario and the Ministers Advisory Council on Special Education. As part of PPM 140, schools must offer students with ASD special education programs and services implementing ABA methods which include, positive reinforcements, providing choices, visuals, modeling, and functional behaviour assessments and have plans in place to support students through transitions between various activities. Previously, every school received an annual survey that focused on the implementation of ABA methods in schools that the board would then submit to the Ministry of Education. A new survey tool is being prepared for spring 2025 and will continue to monitor school board implementation of PPM 140 realizing that ABA methods are just one form of interventions that are supportive of students with a diagnosis of ASD.

- J. Shuttleworth presented an update about the funding from the Ministry of Education which KPR receives each year to run social skills groups. In past years KPR has contracted this service to local community service partners who ran the groups after school either in-person or on a virtual platform. Some students faced barriers as not all students are able to attend after-school programs. This school year, the program will be managed by KPR throughout the school day with the hope of reaching more students. Programs will be offered for students in primary, Grade 2 and Grade 3 and in Grade 7 and Grade 8 (to support transition to high school programs). A secondary school group is also being offered on-line. KPR is using evidence-based programs, AIM Explorers for elementary and Peers for secondary. These programs are currently being piloted at three schools in the primary division, Chemong Public School, Edmison Heights Public School and Kawartha Heights Public School. The plan is to launch the program across the district in January 2025. Groups are being facilitated by C. Cook, Behaviour Support Assistant and S. Timlin, Child and Youth Worker under the direction of H. Cushing-Gordon, Registered Behaviour Analysis.
- D. Crawford, System Principal of Special Education, reported that the Joint Protocol for Student Achievement has been completed. The protocol was written in collaboration with several children's aid societies, KPR and three other Ontario school boards and will be introduced to the principals and vice-principals at the December meetings.

SPECIAL EDUCATION ADVISORY COMMITTEE REPORT

The committee heard about the new modified schedule plan. The plan is a guide for schools who are requesting modification to a student's schedule. The request will be to reduce instructional hours for a student and will outline the intentional and specific strategies and goals for the student to gradually increase capacity and participate in the full instructional day. The programming goals, environmental conditions and organizational structures should be taken into consideration when creating the plan. The possible reasons to modify a student's day were outlined.

The modified schedule plan provides the board the ability to track all modified students and will include transition plans.
